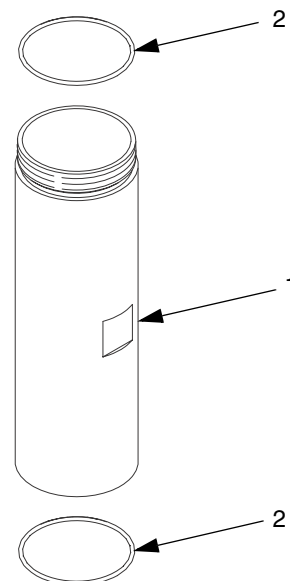

The T2 extension tube increases the length of the T2 transfer pump by 6.25 in. (159 mm) to reach material in the bottom of most 250 gallon (956 liter) totes.

Installation

1. Relieve pressure. See T2 instruction manual.
2. Use a chain wrench near the top of the suction tube (S) and a wrench on the flats of the foot valve (F). Remove the foot valve from the suction tube and discard the o-ring.
3. Install the tube extension (1) and new o-ring (2) on the suction tube (S). Keep the chain wrench in the same position and tighten the tube extension (1). Torque to 10-12 ft-lbs (1-1.3 N•m).
4. Install foot valve (F) onto the tube extension (1) with the other new o-ring (2). Use a wrench on the foot valve (F) and extension tube flats (1). Torque to 10-12 ft-lbs (1-1.3 N•m).

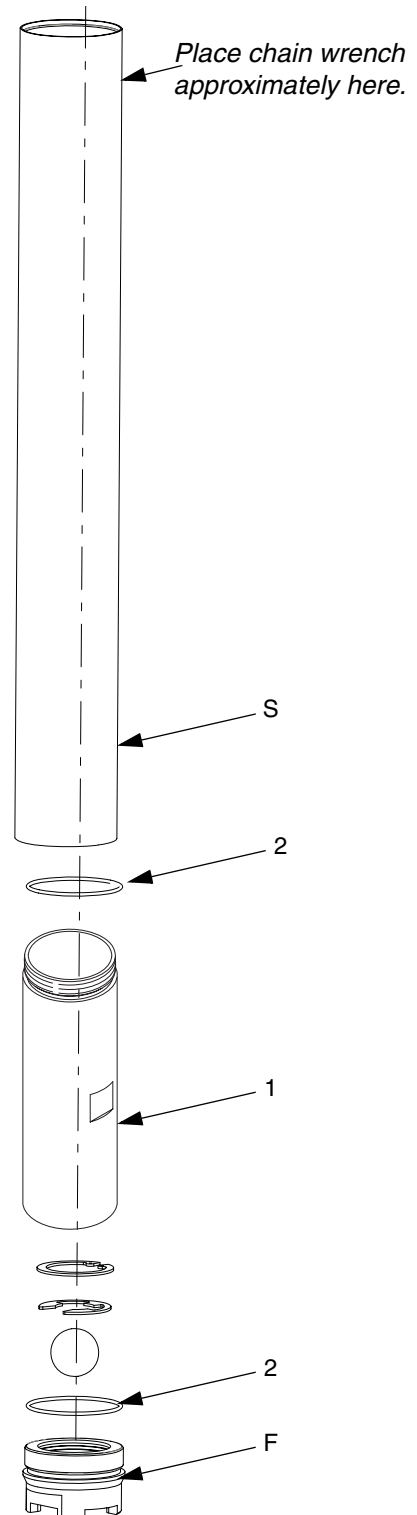
